





19 Days of Activism - Excerpt from the activity report received

The theme was based on Sierra Leone's past history and the fast approaching 2018 elections, especially now that the country is facing lots of violence between political parties, intra-party disputes and community electoral events. According to the police, young people are more involved either used by ill motivated politicians or their colleagues with the intention to be political icons/champions. As local Coalition member, they selected the Campaign theme 15: Addiction and substance abuse

The Goal was "to advocate against the use of substance and abuse towards children and youths during electoral events".





1-19 November

The objectives included:

- 1. To design and launch signature pledge cards with the slogan "Keep-away from electoral Violence Love One Another (KEVLO).
- 2. Generate views through debates on social media and also inform members of the groups on the danger of addiction and substance abuse with a perspective of how to control the use of alcohol during electoral events.
- 3. Engage mass media to promote non violence, discourage alcohol/drug intake during and after electoral events.
- 4. Mobilize support from school head boys, prefects, scouts and girls guides in ten (10) schools in communities in the Western area in rural and urban Districts to help educate peers.
- 5. Organize one day follow up stakeholders dialogue Forum on addiction and substance abuse with the slogan "Keep-away from electoral Violence Love One Another (KEVLO).

Purpose

The purpose of the stakeholders follow up dialogue Forum was to map out strategies that the Network Movement for Youth and Children Welfare (NMYCW) and partners can use to help maximize the campaign under the 19 Days of Activism in 2017. The Forum meeting also served as a platform to follow up on past Network activism outcomes in 2016. At the end of the stakeholders follow up dialogue Forum, partners are expected to slate action points that will be used to engage Government and Ministries, Departments and Agencies, including the Law Reform Commission, to enact alcohol and drug Laws/policies or review existing Laws/policies with a focus more on punishment than prevention. The development of alcohol and drug Law/policy will largely depend on maximizing the NMYCW advocacy initiatives against addiction and substance abuse towards children and youths before, during and after electoral activities across the country.

Problem Statement

Cognizant of the fact that Sierra Leone is a post conflict country with a long history of electoral violence which emerges from increased alcohol and drug addiction and abuse by young people. There are lots of practical evidences on the ground and from reports on election related violence, which is mostly perpetrated by young people and sensored by some politicians. Politicians are on record to use alcohol and drugs as an instrument to get innocent young people into various acts of violence during election related activities. Furthermore, another problem is how the Network Movement for Youth and Children's Welfare and partners advocate/campaign to end or reverse the acts of violence perpetrated by young people in communities as a result of alcohol and drug abuse during every electoral period in Sierra Leone.

General Situation Analysis (summarized)

In Sierra Leone, alcohol and drug abuse has contributed to a series of election related riots and violence. Sierra Leone is perceived as a conflict-prone nation because of her multi-ethnic, cultural, political and economic differences and affiliations. The country, however, has faced intermittent economic turmoil and political crisis since the time of independence in April 1961. Sierra Leone has held 11 parliamentary and 5 presidential elections since independence. All have been accompanied by violence. In the 1967 elections, the ruling SLPP used new public order legislation and array boys – thugs – to stymie opposition. In 1982, more than 50 people were killed in an election conducted in a one party state.

Activities

The Network Movement for Youth and Children's Welfare (NMYCW) designed a one-day program agenda for the dialogue Forum, starting with a call to order and the observance of prayers in both Muslim and Christian faiths. The Chairperson gave a brief overview of the activities of the Network stating that the advocacy initiative is timely as we are fast approaching 2018 election. He stated that since the electoral activities and processes have started, young people are seen in the streets abusing alcohol and drugs nearly during every political activity. He therefore implored all present to take the dialogue Forum very serious and make their own contribution on how to remedy the situation in reducing violence action/s in our communities.

The **National Coordinator** announced that "the 19 Days of Activism as an initiative of many groups across the globe and that this year's campaign theme was selected based on the need". He introduced the Campaign partners and those who supported the program despite the multiple challenges. He said most parents sent their children to campaign activities ignorant of the situation that will befall them. He urged all advocacy/campaign partners to redesign a new road map to mitigate the issues of young peoples' involvement into electoral violence as a result of alcohol and substance abuse in Sierra Leone. Participants were informed that 30 organizations are working as partners in the campaign at local/national level and he also gave a vivid information of the campaign at the international level.







The Chairman of the Sierra Leone Alcohol Policy Alliance (SLAPA), Mr. Ibrahim Kamara made a statement that Civil Society Organisations (CSOs) gathered together on the issue of alcohol and drug abuse by young people in Sierra Leone especially during election periods is a step in the right direction. He also gave a brief background of SLAPA and its activities over the years, noting that SLAPA will not rest until Sierra Leone as a country enact the alcohol and drug Laws/policies.

The representative from the National Youth Commission (NAYCOM) Miss Jaminatu Jalloh in her statement said that it is an opportunity for the Youth Commission to be part of this discussion regarding young people's involvement in alcohol, drug and or substance abuse especially during electoral times. "NAYCOM is doing all it can to help change the status of youth involvement into electoral violence especially getting involved in substance abuse which leads them into violence. This, she said, will only be achieved with the help of the Network and its general partners.

At the Civil Society level, it is very important that CSOs increase their advocacy initiatives to make national Government enact laws/policies on alcohol and drug abuse and push alcohol producers to abide by those rules, regulations, laws and or policies. Furthermore, drug and alcohol advertisements are not fair because producers use nice and or fictitious images that capture and or lure young people into drugs and alcohol abuse. Alcohol advertisements actually draw young people's attention and involve them into substance abuse and misuse. Marketing of alcohol is also a global concern because alcohol is sold 24 hours a day.

Desmond Kanneh from Action Aid International said that he is increasingly surprised to note that electoral activities across Sierra Leone are becoming violent and that mostly young people are the perpetrators. He said "that 18-20 years back young people were not really involved in politics and that it is really pathetic to note that ill motivated politicians are aware of this and take advantage of the innocent and ignorance of young people and buy them alcohol and drugs to get involved in violent activities while pushing their own political agendas. CSOs need to serve as peace ambassadors to help change the mindset of young people before, during and after electoral activities across the country."

Abdulai Jawo Bah, representative from the Pharmacy Board, stated he would like to start with a quote that he learnt from his boss. "By the turn of the century, we are going to replace ideology with science". The idea is that a good number of health professionals know far more definitive information about English football clubs than they do about heroin addiction, who is taking heroin, why are they doing it, and what treatment methodology works. It is a disgrace and this is why the stakeholders follow up with a Dialogue Forum, which is very important to all of us here today."



"You have come here to share your thinking about what is unarquably in my own judgment the key issue in the national drug strategy - the prevention of drug misuse and abuse. Many of you have devoted your entire life trying to understand and deal with the problem of substance abuse in Sierra Leone. We, through the Ministry of Health and Sanitation, want to emphasize a comprehensive approach to addressing substance abuse in Sierra Leone rather than just picking on one variable and addressing that. We have to remind ourselves that drugs are not inevitable. 80% of our children have never touched an illegal drug. But we do have a problem, and we have to get moving. We have to get organized. We are also going to have to listen. Drugs are wrong and you have to uphold the law. We must have law enforcement authorities to address the issues because, if we do not, prevention, education and treatment messages will not work. But having said all of the above, we need to make a case and we need to talk to our Government representatives. We need to back up what we have intuitively learned throughout our professional careers, which is that **drug prevention** is the absolute centerpiece of a sensible national drug strategy. I would like to suggest that we take a long term approach and encourage a sense of partnership. You have to tutor others and the Sierra Leonean people using information from scientific inquiry on what works and does not."



1-19 November



The launch of the 19 Days of activism campaign was done afterwards while moving to the second phase of the program.

Outcomes

- 1. Engage Government and Law makers to review Sierra Leone alcohol and drugs Laws and policies
- 2. NMYCW and partners agree to maximize advocacy initiatives with increased support from CSOs
- 3. The need for getting young people out of alcohol and drugs was shared by participants
- 4. Partners pledged their support to the advocacy initiatives
- 5. CSOs participants accessed credible information on drugs and alcohol abuse by young people and promised to share the information with youth and other organizations.

Action Points

The following were some of the key actions points slated out of the discussions from the Dialogue Forum and to be implemented by NMYCW and partners. Key players were identified and the engagements issues placed under three levels as stated below.

SCHOOL ENGAGEMENTS

Media Coverage of the 19 days of activism

Due to the collaboration and good relationship with the media the organizing team started wide media engagements with hot spots programs on 6 November, starting with Eagle FM, AYV, SLBC, CULTURE RADIO, SKY and AIR RADIO. The coordinator and other members from NMYCW, YPPD and YACAN were hosted to talk on this year's 19 days of activism.

During the follow-up Dialogue Forum, television stations from STAR & SLBC and some Radio stations and printed press also covered the opening session, later these media houses made broadcasts after the program. The campaign team went into agreement with Sierra Express media, one of the leading online newspapers in Sierra Leone, to publish details of the outcome online. Also a video copy will be uploaded on YouTube, several websites including our Geneva official website for people around the world to access.

School engagements

"The campaign team met at the end of the first week of November 2017 and selected the four presenters to talk to the school children in all selected schools for this year's campaign. The speakers are Habib Kamara - SLDCYC, Mathias Bendu - WADN, Abdul Bundu - SLTU/NMYCW and Isata Sidibay - student IPAM. Due to unforeseen circumstances beyond our control Mathias Bendu and Habib Kamara traveled to Ghana for a conference on Drugs/Alcohol abuse, but later returned and presented during the follow-up dialogue forum sessions. The team met and reviewed the messages before official letters were sent to various principals of schools."

The children were allowed to ask questions and the need for clarification after each presentation. As planned the presenters asked each pupil to PEN down a short message to their peers on a van and took a group pictures to mark the end of each school engagement.

The campaign reached out to 15 and 25 pupils per school, which meant **close to two hundred children were reached in almost ten schools** (FAWE PRIMARY SCHOOL, SAINT EDWARDS SENIOR SECONDARY SCHOOL, SIERRA LEONE MUSLIM BROTHERHOOD SENIOR SECONDARY SCHOOL, M. S . PRIMARY SCHOOL, KOREA JUNIOR SECONDARY SCHOOL, LAWENZO - GOVIE SENIOR SECONDARY SCHOOL, PENNUSILLA JUNIOR SECONDARY SCHOOL, JUSLIM INTERNATIONAL ACADEMY).

- Parents have taken up more responsibilities as regards child rights, i.e more children were received at health centres, more children have been sensitized on their rights.
- More local leaders have shown signs of being more responsible when it comes to issues of child abuse.

What campaign materials were used and disseminated, and how you advertised your events

- We used posters, fliers, stickers and the yellow 19 November ribbons were disseminated to different schools and communities were we went to.
- We advertised our events via social media, created an event page were we invited friends and friends of friends and the population at large.
- We also advertised our events via the local radio stations, which included Sky FM and Mbona FM. We also advertised our events by putting up banners in the trading centres.

Initially we had planned to reach out to <u>40,000 given</u> the support <u>we received</u> from <u>different communities</u> going by the previous year's activities but we managed to surpass our anticipated target because of engaging in different forms of media like radio, social media, posters and fliers and <u>we managed to reach out to 67,090 people.</u>

"This report elaborates how Women of Uganda (WoU) approached the 2017 activism campaign for prevention of abuse and violence against children and youth using different platforms in the different areas and the final event at Kyengeza Secondary School with the utilization of the visual campaign material from the global organizers partners Women's World Summit Foundation (WWSF) - Children section , Women of Uganda (WoU) being a women focused organization we joined this 19Days Activism Campaign this year with an intention of reaching to more communities through our already existing community structures in a move to scale up on the activism message dissemination which enabled us reach out to an estimated population of 65,580 people a number which goes over sightly above the people reach out to during the 17days activism campaign for empowerment of rural women this was reached at by engaging in different forms of media like radio, social media, posters and fliers 75% of this being young women and adolescent girls between the ages of 15 - 35years and remaining 25% being adults mainly caregivers and guardians with awareness - raising sessions, sensitizations, trainings with one lead message "violence against children has no space in the modern day life"

The 19 Days campaign also serves as a reminder to governments that ratified the Convention on the Rights of the Child, to prioritize prevention, one of the overarching recommendations proposed in the UN Study on Violence Against Children.



Report on 19 days campaign

Udisha, WWSF coalition partner for the last 15 years and Laureate of the 2010 Prize for prevention of child abuse, organized various events to mark the 19 Days Campaign in 2017.

A national campaign was organized in collaboration with Bhagidari Jan Sahyog Samiti, another national level NGO. The Ministry of Women & Child Development, some Departments of the Government of India / Government of Delhi and 10 other NGOs, Bank and educational institutes participated in the Campaign. The other partner organizations included: the New Delhi Municipal Council; the National Institute of Education & Development Society & Sports Council; All India Institute of Public & Physical Health Sciences; Adim Jati-Tapsil Jati Adibasi Praktan Sainik Krishi Bikas Shilp Kendra; Indian Media Welfare Association; MH One Channel; AcmeFY Softech; Indra Prastha Apollo Hospital, State Bank of India; Vidya Training Institute; Shiv Vani Model Senior Secondary School and Guru Harkrishan Public School.

The Campaign consisted of a national level seminar on prevention of child abuse and child trafficking. The Seminar was sponsored by Delhi Legal Service Authority. The sessions included: Role of Delhi Legal Services Authority in prevention of child abuse and Role of schools in prevention of child abuse; Role of parents in providing safe environment for growth to their children, prevention of child abuse; Role and responsibility of Government in prevention of child trafficking; Awareness about the role of law enforcing agencies in prevention of child abuse and child trafficking.





The Campaign was inaugurated by Minister of State for Women & Child Development, Government of India; Ms. Krishna Raj; Key Note address was delivered by Justice Ms. Sangita Dhingra Sehgal; other eminent speakers included Mr. Ramesh Negi, Retired Principal Secretary, Government of Delhi, who is presently the Chairman of the Delhi Commission for Protection of Child Rights (DCPCR); Ms. Geetanjali Goel, Addl. District & Session Judge / Special Secretary of the Delhi Legal Service Authority; Mr. Ajay Chaudhary, Jt. Commissioner of the New Delhi Police; Mr. Jasbir Singh Nirmal, Director of the Guru Harkrishan Public School Society.

Around 500 Teacher Trainees from District Institute of Education & Training, students and teachers from different schools and representatives from participating NGOs and other Institutions participated in the Campaign.

In her inaugural address, **Ms. Krishna Ra**j, Hon'ble Federal Minister of State (Women & Child Development) mentioned about the role of the Ministry in all round development of children and the programs being organized besides the schemes being implemented across various states of India. She stated that there has been a rise in crime against children during the last 4-5 years. Child prostitution, sexual child abuse in the schools and by close relatives is a menace. There is necessity for arousing awareness amongst the children, parents and their teachers and general public about the crimes against child so that they have normal growth and become fearless citizens.

Justice Sangita Dhingra Sehgal, Hon'ble Judge, Delhi High Court, delivered Key Note address, wherein she touched upon the reforms in the laws for prevention of Child Abuse, particularly the Protection Of Children from Sexual Offences Act. 2012. The Act provides for protection of children from offences of sexual assault, sexual harassment and pornography and provide for establishment of Special Courts for trial of such offences and empowers the State to make special provisions for children. The Act contains provisions of more stringent punishment for sexual offenders, which serves as a deterrent for such crimes.

Mr. Ramesh Negi, Chairman DCPCR, mentioned that there are several laws for protection of child rights and prevention of child abuse. The constitution guarantees education, health and care and safety of children and the mandate of the Commission is to protect the child rights and ensure that the laws relating to children like child labour are enforced. He also raised the issue of all round growth of children and abolishing the system of child labour and bonded labour.

Ms. Geetanjali Goel, Addl. District & Sessions Judge / Spl. Secretary DLSA, explained the services like awareness and training being provided by the DLSA for the protection of child rights and of prevention of child abuse and child trafficking.

Mr. Ajay Chaudhary, Jt. Police Commissioner mentioned about the rising number of missing children. He also said that the role of the Police is not only to maintain law and order but they also have to ensure that there are no instances of sexual, emotional and physical abuse. He elaborated the role of police in protection of child rights and stated the police is redefining its role in the light of latest provisions of law and implementation of Prevention of Children from Sexual Offenders Act (POCSO Act). He urged upon the public to spread awareness about the sexual child abuse and ensure the participation of the public for protection of child rights.

Dr. Rajinder Dhar, Additional Labour Commissioner, Government of Delhi spoke about the rescue and rehabilitation of child labour, a worst form of child abuse. He elaborated upon various provisions of Labour Laws and advised the audiences, particularly students to report about employment of child labour in any establishment or industry, through Helpline of Labour Department so that the Task Force could take action for their rescue and rehabilitation.

During the program, a Suggestion competition was also organized based on the theme of the Seminar: How to prevent child abuse and stop child trafficking. Three best suggestions were awarded, i.e. 1st, 2nd, 3rd prize and 7 Special Prizes were also awarded to students giving good suggestions judged by the Jury. The awards and certificates were given away by Ms. Krishna Raj, Hon'ble Federal Minister of State (Women & Child Development).

During the campaign a Walk on Prevention on Violence against Women, AIDS and Legal awareness also took place. Around 500 students from District Institute of Education & Training, Gurugram, Haryana, participated. They displayed posters and raised slogans about awareness on these burning issues facing Indian society. With the involvement of Indian Media Welfare Association and MH One Channel, the event got wide publicity in print and electronic media and the outreach of 19 Days Campaign increased manifold.

PALESTINIAN TERRITORY

Gaza Community Mental Health Program, Gaza City



Palestinian citizens in Gaza have been living under the Israeli blockade for more than 10 years. The blockade has increased the humanitarian and development situation of Palestinians in Gaza who have endured three Israeli military offensives in less than six years that caused many civilian casualties and left tens of thousands of Palestinian families homeless. Gaza is the "world's largest open-air prison", where citizens are deprived of the most basic human rights such as adequate electricity supply, access to clean water, health services, and education. These current conditions have impacted the psychological wellbeing of the people in Gaza. The mounting frustration, anger and hopelessness of the people of Gaza have contributed to an increas-

ing sense of distress and despair. Violence and abuse rate is increasing among youth and children. In order to fight violence against women, children and youth GCMHP conducted several activities to raise the public awareness of the multifaceted problem of violence and abuse.

The activities included the following:

a) Print and install a billboard poster designed with a slogan "Talk", the billboard design described how violence affects all family members and not only the ones directly facing violence and it clearly showed the free number for telephone counseling.

- b) Broadcast 6 Radio spots (ads) spots on different topics on sub-types of violence (listed below) were broadcasted in three local radio stations
- · Denial of MH services
- · Denial of education rights
- Forced marriage
- Physical assault
- · Emotional abuse
- Violence against youth

c) Radio programs

7 radio episodes on violence and how to protect children from violence and abuse were broadcasted which discussed the following topics:

- · How to deal with children during a crisis
- Family problems and its influence on children
- · Solving children and family problems in creative ways
- · Children delinquency in Gaza
- · Impact of violence against women on children
- · Violence inside the schools
- Addiction

d) Produce and broadcast 1 video spot

It was planned that the production of the video spot should be through a talented youth competition to enhance youth participation in the community. The competition results for the ranking were announced during an event that was held on the occasion of International day of the elimination of violence against women on 25th November 2017. The competition and the winning videos had captured the attention of the local media outlets and had a great interaction from people on social media. The competition was a great idea to spread the awareness messages on violence among youth and from youth themselves.







The winning videos included:

- A screaming soul, with a focus on verbal / physical violence.
- Violence and generations: with a focus on how violence can be transferred through generations.
- · Moment, which discusses the problem of Cyber bullying
- e) A video promo on women, youth and children violence was published on social media and it was posted on street screens and it explains how violence affects all family members.

f) Brochure

A brochure on VAW and how it affects the mental health of women and children, was prepared. 3000 copies were printed and distributed at public meetings held by GCMHP.

Cooperation for Peace and Development (CPD), Kabul, Afghanistan

CPD focused on organizing sports tournaments, youth camps and e-campaigns as the main strategy of its activism on elimination of violence and abuse against youth and children.

Campaign slogan: "Education Reduces Child/Girl Marriage". CPD's planned online activities for 2017:

Ombudsman for Children, Teslina 10, HR-10000 Zagreb, Republic of Croatia



Brief description of the organization

The institution of Ombudsman for Children of the Republic of Croatia was established in 2003 by the Ombudsman for Children Act, as a parliamentary institution and the first specialized institution of its kind in the Republic of Croatia, with the aim to monitor, protect and promote the rights and interests of children. We work on four locations: in Zagreb (headquarters) and in three regional offices in other major cities in Croatia (Osijek, Rijeka and Split). The office has a multidisciplinary team of 19 people.

Our office has access to various groups of children because we visit children placed in institutions or with natural and legal persons and other legal entities on the basis of specific regulations. We also have our Network of Young Advisors to the Ombudsman for Children (NYA). Members of the NYA actively participate with our staff in discussions in many different areas on daily basis and during our thematic meetings. It consists of 20 members – children aged 12-18, who are advisors to the Ombudsman for Children, associates and promoters of children's rights among peers and adults.

19 themes covered by the campaign

Activities that we undertook during the campaign focused on many of the 19 campaign themes.

- On 10 November 2017 we made a public announcement about the annual campaign "19 Days of activism for prevention of abuse and violence against children and youth 1-19 November 2017" on our website www.dijete.hr/www/?p=11099.

We presented the campaign and the Prevention Kit.

We emphasized and reminded about the goals of the campaign and called for participation in marking the **World Day of Prevention of Violence against Children.** We have continuously called for systematic action to prevent any form of abuse and neglect of children. This also includes our recommendations and annual reports where we advocate for implementation of certified prevention programs regarding violence among children in schools, education for non-violence and non-violent conflict resolution, as well as strengthening children to seek help when in danger or exposed to physical, mental or sexual violence. We also remind about the need to enhance the participation of children in the activities regarding the prevention of violence.

An excellent example offered is the Network of Young Advisors to the Ombudsman for Children (NYA). In 2016 they adopted a strategy NYA Peer Violence Prevention Strategy, titled Let us break the silence that hurts which was presented to the public.

- In November 2017 members of our office visited different institutions for children around Croatia, which also include meetings with children, promotion of children rights, especially the right to protection from all forms of violence and participation of children, in light of the campaign (information available at www.dijete.hr),
- In November 2017 members of our office participated at various events organized by other institutions and made presentations promoting children's rights (information available at $\underline{www.dijete.hr}$).
- Central event took place on 20 November 2017 in our office in Zagreb (premises of our "Little House of Children's Rights")

In 2017 we encouraged secondary school students of **School of Art, Design, Graphics and Clothing in Zabok to** create illustrations regarding the Convention on the Rights of the Child, which were used to create 2018 Calendar of the Ombudsman for Children, entitled "I know and I respect children's rights". Opening of an exhibition of their art works took place **on 20 November 2017 in our office in Zagreb.** The exhibition and calendar is a result of a cooperation of Ombudsman for Children with the secondary school students in joint commitment that the UN Convention on the Rights of the Child comes closer to children and young people with its significance and messages.

Many different participants/stakeholders participated in this event, as well as many children, including members of our Network of Young Advisors (NYA). The exhibition will be open until the end of 2017. Information available at http://www.dijete.hr/www/?p=11111.

Through the public announcement of these activities we have contributed to raise awareness and to inform **the general public and the media** about 2017 Global Campaign "19 Days of Activism 1-19 November" & "World Day – 19 November".

All the events received media coverage. We can estimate than a large number of children and adults, including relevant institutions and stakeholders have been reached and will be reached by these activities, including participants in all events and a larger public via media releases and our website.



FICE Romania, a non-profit professional organization, whose main mission is to protect and promote the rights of the child in Romania since its inception in 1990, continued in 2017 the association with the campaign initiated by the Women's World Summit Foundation, based in Geneva, Switzerland.

In 2017, the Campaign took place under the high patronage of the Romanian Senate (Commission for European Affairs) and in collaboration with the National Authority for the Protection of Child's Rights and Adoption, which created the framework of active involvement in the prevention of abuses and violence of any kind against children and youth for local communities, ministries, schools, kindergartens, children's and youth centers, children's clubs, day centers, etc.

In September 2017, FICE Romania sent the call for association to the campaign throughout the country, and collaborated with the Ministry of National Education, the Ministry of Labour and Social Justice, the Ministry of Internal Affairs, the National Anti-Drug Agency, the National Anti-Aging Agency Trafficking in Persons, Ministry of Health and at regional and local level, with their decentralized structures (school inspectorates, general directions of social assistance and child protection, public health directorates, police inspectorates, county centers for antidrug assessment and counselling, regional centers anti-trafficking, etc.) as well as with other NGOs.

Both national and local level participating in the campaign, its goals and objectives were presented by the media (printed media, central or local television stations, social networking sites - facebook), as well as in each school.

Both the WWSF submission kit and its own materials (posters, flyers, messages, etc.) created throughout the campaign were used to perform the activities.

The experience gained since 2012, the year in which FICE Romania carried out the first campaign to prevent abuses and violence against children and young people, led to the participation of over 200,000 pupils in nearly 2,000 schools in more than half of the counties of Romania (Alba, Arges, Botosani, Bacau, Buzau, Caras-Severin, Calarasi, Constanta, Covasna, Dolj, Giurgiu, Gorj, Iasi, Ilfov, Maramures, Mures, Olt, Prahova, Neamt, Satu Mare, Teleorman, Timis, Vaslui, Valcea, Vrancea and Bucharest).

More than 10,000 teachers, psychologists, police officers, social workers, journalists, physicians and parents also participated in the Campaign.

Also, local institutions (public social assistance services from the **512 localities** involved), county (DGASPC Mures, DGASPC lasi, DGASPC Suceava, DGASPC Vaslui) and child protection centers as well as other NGOs active in the field of child protection (AD- DGASPC).


In the participating schools, the children prepared under the guidance of teachers, drawings, posters displayed on the hallways, panels made specifically for their messages to be seen, read and known by other children, officials, parents, etc.

Such an exhibition was carried out by the children in the counties of Arges and Constanţa and exhibited in the Senate of Romania throughout the campaign (1-19 November 2017).











At national level, FICE Romania organized at the Parliament Palace on November 16, 2017, with the support of the National Authority for the Protection of Children's Rights and Adoption, the Association of Directors of the General Directorates for Social Assistance and Child Protection (AD-DGASPC) and the Association of Communes of Romania ACoR), a National Conference with International participation "Prevention of Child Abuse and Violence, Public Policies Responsible in the Field of Violence and Promoting the Rights of the Child".

It was the first time when, convened by a nongovernmental organization, mayors and representatives of central and local public authorities came to the representatives of the school, the social protection system of the child and the civil society to say what they were doing to diminish in their area of responsibility for violence against children.

Local councils, local councils, school inspectorates, general directorates of social assistance and child protection, pre-university education units, universities, church exponents, police, doctors, etc. were represented. The conference was a good opportunity to bring together specialists from all over the country (Bucharest, Constanta, Vaslui, Calarasi, Arges, Neamt, Giurgiu, Timis, Arad, Bacau, Ialomita, Iasi, Ilfov, Dambovita, Suceava, Alba) and from abroad (Germany and Austria).

Representatives of the Romanian Senate, the National Authority for the Protection of Child's Rights and Adoption, and the media have also participated.





Scientific papers, examples of good practices in the field of child abuse prevention, conference speeches have been brought together in a volume that appeared at Semne Publishing House and which has the role of contributing to the training and information of school specialists and in the field of child protection.

Also, at the events organized by the 19 Days Campaign in Bucharest, FICE Romania, the Ministry of National Education and the Bucharest Teaching Staff House, organized a national symposium. The attitude of the child in the game - reflection of the parental model, are presented in a methodical- scientific publication, a collective volume that appeared at Tiparg Publishing House.

Results of the 2017 Campaign: Prevention of Violence Against Children and Youth

- 72 workshops, roundtables, debates, participation in local, regional and national TV station broadcasts.
- Over 2300 direct activities with and from children in kindergartens and participating schools.
- Over 500 meetings with parents or grandparents and relatives of children (in situations where parents are going to work abroad).
- Over 1,400 meetings with specialists (policemen, doctors, psychologists, priests, etc.)
- 7 forum theater sessions, 6 films made by students, puppet theater (puppets)

Following the 19 Days Campaign to prevent child abuse and violence, FICE Romania issued an appeal and drafted a handout for the Ministry of Labor and Social Justice, the Ministry of National Education, the Ministry of Health, a document containing a series Suggestions for <u>Creating a Safer Environment for Children in Romania</u>:







- Developping clearer regulations for the protection of children while in school;
- Amending legislation on adoption;
- Funding for safe child safety;
- Allocating funds to enable municipalities to put into practice social and educational services for which premises have been built, and which are closed for lack of material resources;
- Creating centers with educational and social protection functions for students, centers that involve more communities, according to the model of agricultural associations;
- Studying adequate interventions, enclaves more or less closed social groups (neighbourhood's);
- Interdisciplinary work in education, social protection, prevention, health care;
- Employing family doctors in child raising issues;
- Stopping the phenomenon of marriages under the age of majority;
- Enhancing family-school partnerships;

WWSF received the following report and an official video of their road action. https://youtu.be/yUgWSqHN wo Attached you will find some pictures of our information activities in the Old Town of Basel, Switzerland, on 11 November 2017.

"We caught the attention of the street public with the clatter of wooden spoons, with yodels and with putting up the campaign banner on street corners. People passed by, saw no one and looked at the street banner more closely. We then approached them and talked to the people to let them know what the road action was all about. Many people said that they consider this information campaign to be very important because there is still too little information about where children and adolescents affected by violence and abuse can get help. It was also well received that the info-site holdirhilfe.ch has been translated into 9 languages. The people appreciated getting 'Hol dir Hilfe' cards fitting well in their purses.

We had talks with adults that suffered violence and abuse in their childhood and adolescence. There were also passers-by who know teens that are currently suffering violence. They took holdirhilfe.ch cards to give to these youngsters as soon as they see them again.

It was a very interesting and a good experience, especially concerning the reactions of people in the streets. We learned that it is important to be in good mental and emotional condition when we want to speak to people about violence and abuse against children and youth, and that we have to perform this action next time with young adults and with a multicultural background.

It was an intense preparation time. It took courage to go out on the streets with this theme. Nevertheless, we decided to carry out this action again next year, in 2018."



"We are a leading anti-Female Genital Mutilation charity, working to end FGM in Africa and the diaspora. For the 19 days campaign, we organised a social media campaign that highlighted the impact of child violence and FGM through engaging activists and highlighting selected statistics from our research reports on FGM.

Campaign posts were put out daily on Twitter, Facebook and Linkedin highlighting FGM statistics, stories, poems and quotes from activists on the theme of "what are you doing to prevent child violence?" Everything we ran during the 19 days campaign carried the hashtag #19daysofactivism. However, we didn't feel that there was a dedicated hashtag to use for the campaign that connected all those taking points and we think this would have been very useful. The idea of our campaign was to raise awareness of violence against children and make research available to people and organisations who are working to end such violence. In addition, we launched our latest Country Profile report on FGM in Eritrea on day 13 of the campaign. The launch included a twitter chat on the theme of "Harmful Traditional Practices" with a panel of 3 experts, Fatma Naib, a Swedish-Eritrean journalist, Lorna Andisi, a communications and SRHR specialist from Kenya, and Nnamdi Eseme, a writer and SRH specialist from Nigeria. Overall we were happy with the results from our campaign."
